IV. Financials

- a. Treasurer's Report. Balances as of end of day 31 May 2022.
 - i. Debit Card: \$227.06
 - ii. Checking Account: \$34,056.21
 - iii. Reserve Fund: \$29,116.24

V. Parks Committee and Common Areas

- a. Chris Headlee reported and fielded some questions.
- b. Park 1 Priority
 - i. Rock between the pathway and the lots (weed fabric down first).
 - 1. Have an estimate of area and will calculate rock needed.
 - 2. Chris Olney will then provide a quote on cost.
 - 3. Logistics? How do we get it into park one and spread it?
 - ii. North side of Park 1
 - 1. Mix of rock paths and xeriscape open "natural" areas.
 - 2. Sprinkler pipe stubs. Some need to be capped off below ground.
 - 3. Clear off the dry weeds.
 - 4. Sand Volleyball Court
 - 5. Horseshoe pits
 - iii. Parks 2 and 3
 - 1. Signs at the easement entrances.
 - 2. Concrete and debris cleanup first step.
 - Simple winding walking paths in parks 2 and 3

 decomposed granite
 - 4. Xeriscaping parks 2 and 3, some natural areas

Clean-up day to clear weeds/debris outside of the path of Park 1, weed the playground, and to remove the junk concrete / debris from Parks 2 and 3. Scheduled for **Saturday 25 June**.

Tree replacement

1. There are seven trees in Park 1 that need to be replaced.

- 2. Tree options have been researched, plus visits to Big Trees and Ladybug nurseries.
- 3. Trees will be ordered and delivered. Delivery scheduled for Thursday 16 June. Do planting on Friday & Saturday morning.
- 4. Will need help with planting and watering
- c. Common Area Park 4 (northeast)
 - i. Signs vs Fence or both to keep ATVs at least 100 ft from properties.
 - ii. Need to flatten the area within the 100 ft buffer.
 - iii. No 2-stroke engines allowed.
 - iv. No cars or trucks.
 - v. Need "No Trespassing" signs at the canal bridge.
- d. 2300 West pine tree irrigation
 - i. The water line works. Need to replace the controller unit.
 - ii. Some of the lines are damaged. Need to repair/replace.
 - iii. When the irrigation is repaired, we will plant 3 pine trees on the south side of the south entrance.
- e. Common Area Lease agreements
 - i. List of restrictions and permitted use need to be sent to the attorney to draft lease agreement forms.
 - ii. Plan is to have different criteria for limited common areas.

VII. Speed limit lowering
